

\$2.5 K Cashback Offer Terms and Conditions

- The Offer is only open to Australian residents aged 18
 years or over, including employees of MOVE Bank and
 their immediate family.
- This Offer commences 04 May 2021 and closes 30 June 2021 ("Offer Period")
- 5. To be eligible for the Offer a borrower must, jointly or individually, apply to refinance a secured residential home or investment loan from another financial institution to MOVE Bank ("Eligible Loan") resulting in new borrowings to MOVE Bank of a minimum of \$250,000 or \$350,000 for broker referred loans.
