

\$2.5 K Cashback Offer Terms and Conditions

Commencing 04/05/2021 – 30/06/2021

1. The '\$2.5K Cashback' Offer ("Offer") is organised by Railways Credit Union Limited trading as MOVE Bank ("MOVE Bank"). AFSL/Australian Credit License number 234 536 | ABN 91 087 651 090. Level 1, 179 Ann Street Brisbane 4001.
2. Information on the incentive and eligibility to claim form part of these terms and conditions.
3. The Offer is only open to Australian residents aged 18 years or over, including employees of MOVE Bank and their immediate family.
4. This Offer commences 04 May 2021 and closes 30 June 2021 ("Offer Period")
5. To be eligible for the Offer a borrower must, jointly or individually, apply to refinance a secured residential home or investment loan from another financial institution to MOVE Bank ("Eligible Loan") resulting in new borrowings to MOVE Bank of a minimum of \$250,000 or \$350,000 for broker referred loans. Where an Eligible Loan application is received during the Offer Period and approved and funded by 13 August 2021, a payment of \$2,500 will be paid to the borrower ("Payment") subject to these terms and conditions.
6. Unsecured loans, secured personal loans and top-ups are not included in the minimum new borrowings amount.
