

First Home Buyers Club Referral Program Terms and Conditions

Commencing 01/06/2021

- The Referral Offer ("Offer") is organised by Railways
 Credit Union Limited trading as MOVE Bank ("MOVE Bank"). AFSL/Australian Credit License number 234 536
 | ABN 91 087 651 090. Level 1, 179 Ann Street Brisbane 4001.
- Information on the incentive and eligibility to claim form part of these terms and conditions.
- The Offer is only open to Australian residents aged 18
 years or over and excludes employees of MOVE Bank
 and their immediate family, and third-party introducers
 such as brokers.
- 4. This Offer commences 01 June 2021 and can be withdrawn at any time.
- To be eligible for the Offer as a Referrer, an individual must be a member of MOVE Bank's First Home Buyers Club and hold a current home loan with MOVE Bank for their first property ("Referrer").
- 6. To be eligible for the Offer as a Borrower, the individual must be referred to MOVE Bank by a Referrer and, jointly or individually, apply to finance or refinance a secured residential MOVE Bank home or investment loan ("Eligible Borrower") resulting in new borrowings to MOVE Bank of \$350,000 or more ("Eligible Loan").
- 7. A payment of \$250 will be paid to both the Eligible
 Borrower and Referrer within 60 days of the settlement
 of an Eligible Loan ("Payment") via transfer into a
 nominated MOVE Bank loan or savings account. The
 Payment will not be made in "cash" (for example: bank
 notes and/or coins) or cheque.
- To be eligible for the Payment, the Eligible Borrower must quote the unique code provided by the Referrer in their online application or mention the Offer during the application process.

- Unsecured loans, secured personal loans and top-ups are not included in the minimum new borrowings amount.
- 10. Offer excludes internal refinance, interest only loans and broker referred loans.
- 11. An Eligible Borrower can only receive the Payment once and no further loans which include that Borrower, jointly or individually, will be eligible for the Offer.
- 12. A Referrer is able to refer multiple Eligible Borrowers as part of the Offer and receive multiple Payments where eligible.
- All loan applications are subject to MOVE Bank's standard credit assessment and eligibility criteria.
